STIPULATION 1 WHEREAS, pursuant to the October 27, 2022 Joint Case Management Statement and 2 3 Discovery Schedule ("Discovery Schedule"), this Court directed the parties to meet and confer 4 and submit to the Court a joint proposed protocol on privilege issues (or, if the parties cannot 5 agree, separate proposed protocols with supporting memoranda) on or before January 19, 2023 6 (Dkt. 440); 7 WHEREAS, the parties previously agreed to extend the deadline for submission of the 8 joint proposed protocol to the Court to February 7, 2023 (Dkt. 465); 9 WHEREAS, the parties have met and conferred and have narrowed the issues before them 10 regarding the joint proposed protocol; 11 WHEREAS, the parties continue to discuss the joint proposed protocol and respectfully seek additional time to resolve or narrow any remaining disputes; 12 13 WHEREAS, the Discovery Schedule states that submission of a privilege protocol to the 14 Court shall not delay Defendants' initial production of discovery called for under Paragraph III.e.i 15 of the Discovery Schedule, and WHEREAS that production is in fact underway; NOW, THEREFORE, the parties hereby agree, stipulate and respectfully request that the 16 17 Discovery Schedule be amended to provide that the parties shall submit to the Court a joint 18 proposed protocol on privilege issues (or, if the parties cannot agree, separate proposed protocols 19 with supporting memoranda) on or before February 24, 2023.
